LABUAN ISLAMIC FINANCIAL SERVICES AND SECURITIES (AMENDMENT) REGULATIONS 2013

IN exercise of the powers conferred by section 156 of the Labuan Islamic Financial Services and Securities Act 2010 [*Act 705*], the Minister, with the recommendation of the Authority, makes the following regulations:

Citation and commencement

- 1. (1) These regulations may be cited as the **Labuan Islamic Financial** Services and Securities (Amendment) Regulations 2013.
 - (2) These Regulations come into operation on 1 April 2013.
